

Sierra Expedition 2012-2013 Registration

You will need to complete 3 forms to register for Sierra Expedition 2012-2013:

- 1) Adventure Guides: Registration Form
- 2) Release Waiver of Liability and Indemnity Agreement
- 3) YMCA of San Francisco Release and Waiver of Liability and Indemnity Agreement

Adventure Guides: Registration Form

A registration form for the Southwest YMCA must be completed to join the YAG program. Here is the registration form and Waiver available as a PDF. This is already included in your Registration packet for 2012-2013 so you don't have to print it out.

Make sure to indicate that you are in the Sierra Expedition and include your Circle name.

Complete the Registration Fees section of the form according to the instructions below (Sierra Expedition 2012 - 2013 Fee Schedule).

Also make sure to sign the YMCA Adventure Guides Parent Code of Conduct on the reverse side of the Registration Form.

Release Waiver of Liability and Indemnity Agreement

This is also included in your Registration Packet for 2012-2013 so you don't have to print it out. Sign it and include it with your Registration Form. The liability waiver for the Silicon Valley YMCA must be signed in order to join the program.

YMCA of San Francisco Release and Waiver of Liability and Indemnity Agreement

Additionally, a separate waiver for the San Francisco YMCA must be signed to attend the Jones Gulch campout. Here is the San Francisco YMCA (Jones Gulch) waiver as PDF. It is not included in your Registration Packet, so you will need to print it out to sign it. It's been included below for your convenience.

Sierra Expedition 2012-2013 Fee Schedule

Southwest YMCA Adventure Guides

You may make a single payment (either by check or by credit card) to participate in the YMCA Adventure Guides program with the Sierra Expedition. Part of your fees go to the Southwest YMCA to cover administration costs of the Adventure Guides program (Program Fee and Program Membership). A second part goes to the Sierra Expedition to cover Expedition event costs (Expedition Fees). The YMCA keeps this account, so you only need to write one check payable to the "Southwest YMCA". It is also possible to charge your Credit Card. See the "Payment Information" section of the "Adventure Guides: Registration Form".

Southwest YMCA Adventure Guides Program Fee

On the "Adventure Guides: Registration Form", enter the appropriate fees: Program Fee (1st child) \$75. Program Fee for each additional Child \$50. "Expedition Fees or Campout Fees" are covered below. Then enter \$25 Program Membership Fee (per child). The Program Membership Fee is waived if you are a YMCA Facility Member.
